OVERVIEW

Metal Arc's Open Plan cabinets provide a low-profile solution for the storage needs of collaborative work environments.


Open Plan cabinets are sold without a finished top. Rather, these cabinets are designed to be ganged together under a common laminate top (customer provided). Optional steel tops are also available – see below.

For ease of installation, all Open Plan cabinets come standard with re-closable fasteners on the top, thus eliminating the need for pre-drilled work surfaces.



Open Plan cabinets are available with two different leg styles: Square and Round.







Round Leg brushed stainless steel finish

To facilitate design flexibility, cabinets can be ordered with or without legs:

Cabinets with Legs Included: When ordered with legs included, each cabinet will ship with four legs (Square or Round), along with attachment screws. To minimize the risk of freight damage, these legs are packaged separately for field installation.



• **Cabinets Without Legs – Legs Ordered Separately**: Alternatively, cabinets and legs can be ordered separately. This is appropriate in instances where two common legs are used to gang two cabinets together, side by side, as illustrated in the pictures below. Ordering cabinets and legs separately is also a more cost-effective option for such instances. Please see below for instructions for ordering legs separately.



• **Cabinets Without Legs – Casters:** Any Open Plan cabinet can be made into a mobile cabinet by adding a set of black casters. See page 5 for ordering information.



<u>IMPORTANT</u>: Open Plan cabinets are designed to be used with legs or casters. Open Plan cabinets will <u>not</u> function properly if placed directly onto a floor without any supporting legs or casters.





The key ranges shown above designate the range of <u>possible</u> key numbers. Metal Arc does not guarantee the availability of all potential key numbers within the ranges.

Core and Key-Only Orders

Metal Arc provides a broad range of lock options in order to facilitate its sales of filing and storage products. Metal Arc does not stock locks in order to sell keys and cores on a stand-alone basis. Accordingly, the following rules apply to any order for lock cores and keys that is not made simultaneously with an order for filing and storage cabinets:

- <u>*Right to Decline Order*</u>: Metal Arc may, in its sole discretion, decline a stand-alone order for lock cores and keys that would deplete its inventory.
- <u>Small Order Handling Fee</u>: A \$10 net processing fee will apply to any stand-alone order for lock cores and keys (including core change keys and master keys) with a total net value of less than \$50.

Keyed-Alike Lock Cores for Field Installation

To order keyed-alike products:

- A. Clearly state "<u>PULL CORES</u>" in the description on your purchase order for any items you wish to have keyed-alike, and
- B. Order the lock core/ key sets as separate line items on your purchase order using the product codes on the prior page. (See below for an example.) Metal Arc will select key numbers to satisfy this request from the key number ranges shown on the prior page.

The keyed-alike lock core/key sets will be packaged separately for field installation.

There is no additional charge for key-alike requests, provided that (a) the key-alike request is made in conjunction with the original purchase order, and (b) the number of core/key sets ordered does not exceed the number of cabinets ordered.

The list price for <u>additional</u> lock core/key sets is <u>\$15/set</u> for all lock styles other than FR locks and <u>\$25/set</u> for FR locks.

Keyed-alike lock core/key sets can be specified as follows:

- A. Determine the number of keyed-alike locks in each workstation on the project.
- B. Group together the workstations with a like number of locks for example, 10 workstations with 2 locks per station, 5 workstations with 3 locks per station and 1 workstation with 4 locks.
- C. <u>For each grouping</u>, enter the number of workstations in the quantity column of the purchase order, followed by the part number for the appropriate lock series. Then add a suffix to that product number for the quantity of keyed-alike locks in that group. For example, to order the lock groupings from Step B with UM Black locks, the purchase order would read as follows:

Metal Arc has access to many industry favorites beyond the standard colors shown above. Please contact us if you are interested in a particular color that is not shown above. If a particular color is available, it often can be obtained on short notice and with little or no additional charge.

Interested in a custom color ...

If you need to match a particular color, provide us with a sample of that color. We will work with our paint suppliers to provide a match - a match that you will get to review and approve before proceeding.

Custom color requests are handled on a case-by-case basis. Additional leadtimes, surcharges and quantity minimums may apply.

FABRICS FOR CUSHION TOPS

Metal Arc cushion tops may be ordered in any color from the CF Stinson[©] – New Hempstead and Bryant Park fabric collections. These fabrics may be viewed at <u>www.cfstinson.com</u>.

CUSTOMER-PROVIDED FABRICS

Customers also may supply their own fabric for use on cushion tops. Please see below for information regarding pricing, quantity requirements and mailing information.

Pricing:

In instances where a customer supplies its own fabric, Metal Arc will apply a credit (price reduction) of \$5 net per unit for an order of 10 or more cushion tops. In order to qualify for this credit, all 10+ cushion tops must be ordered together on a single purchase order. No credit is available for orders of less than 10 units.

Labeling Information: Please provide the following information with your package of fabric:

- Your company's name
- Your purchase order number to Metal Arc (that is, the purchase order for which the fabric is to be used)
- The manufacturer and name of the fabric
- The quantity of fabric provided

Lead Time: Standard lead time is 12 to 15 business days following both (a) receipt of fabric, and (b) submission of a complete purchase order to Metal Arc.

Warranty: Metal Arc's standard warranty does <u>not</u> apply to customer-provided fabric.

HOW TO ORDER

Metal Arc uses a "smart" product code that identifies, in order, not only the cabinet style and drawer configuration, but also the cabinet pull type, paint color and any upgrades/accessories.

TERMS OF SALE

<u>Pricing and Freight</u>: Unless indicated otherwise, all prices quoted in this catalog are list prices, before any applicable discounts. Freight expenses are handled on a case-by-case basis. In instances where Metal Arc is responsible for freight expenses, a small order freight charge may be applied to orders that fall under a particular dollar threshold.

Shipping Costs – Accessories: When ordered on a stand-alone basis (*i.e.*, not in conjunction with an order of casegoods), actual shipping costs will be charged to the purchaser for all orders of accessories.

<u>Order Placement</u>: All orders must be submitted in writing. Orders may be sent to Metal Arc via e-mail at <u>sales@metalarcinc.com</u>.

Order Acknowledgement: Order acknowledgements will be issued via e-mail, typically no later than the end of the next business day after receipt of a purchase order with all necessary information. Please contact Metal Arc immediately if you do not receive an order acknowledgement by the end of the next business day, as your order may not have been received. The order acknowledgement will list the details of your order and correct any discrepancies in pricing. *Please carefully review your order acknowledgement for any errors or omissions*.

Lead Times: Your order acknowledgement will show a date by which your order will be ready to ship. Lead times will be dependent upon order size and product mix. Most small orders for pedestal files, standard lateral files and bookcases will be ready for shipment within 5 to 10 business days of receipt of a clean purchase order. Metal Arc will not be liable for any losses or damages resulting from longer lead times, nor will a longer lead time entitle the purchaser to a right of cancellation.

<u>Changes and Cancellations</u>: Because of Metal Arc's short lead times, purchase orders may not be cancelled after issuance of an order acknowledgement. In the event of a requested change or correction, the purchaser may be required to pay an additional re-stocking or re-processing fee. Metal Arc may, at its discretion, determine the amount of any such fee on a case-by-case basis.

Shipping Terms: With the exception of local deliveries made by Metal Arc itself, Metal Arc's shipping terms are FOB origin. This means that the buyer takes title to the goods (and is responsible for the goods) once they leave Metal Arc's premises. Metal Arc is not responsible for freight damage caused by a non-Metal Arc carrier. For local deliveries made by Metal Arc, the shipping terms are FOB destination.

Freight Delivery Times / Special Requests: In instances where Metal Arc is responsible for freight expenses, Metal Arc will provide free freight to a single destination in the continental United States, for delivery during normal business hours to a commercial dock. Normal business hours for most freight carriers are between 7:30 a.m. and 3:30 p.m. To the extent possible, Metal Arc will work with the chosen freight carrier to accommodate special shipping or delivery requests, such as inside deliveries or weekend and late-night deliveries. *Please be aware that the purchaser is responsible for any additional costs/charges incurred by Metal Arc as a result of such special shipping and delivery requests.*

Please also be aware that a freight carrier may charge a penalty if a purchaser is not ready to accept delivery at the scheduled time. Any additional charges/penalties incurred by Metal Arc as a result of a purchaser delay are the responsibility of the purchaser and will be passed along to the purchaser.

Freight Damage Claims: It is the buyer's responsibility to inspect goods thoroughly for apparent damage before accepting shipment. Please do not refuse shipment. Rather, *if there is any apparent damage to the unit or packaging, please clearly note that damage (in specific detail) on the bill of lading when accepting delivery.* Failure to note apparent damage on the bill of lading or another shipment document may prevent the purchaser and Metal Arc from successfully pursuing a freight damage claim.

Please contact Metal Arc *immediately* in the event of apparent shipping damage, or in the event of damage discovered upon unpacking the product (*i.e.*, concealed damage). As noted above, Metal Arc is not responsible for freight damage caused by a non-Metal Arc carrier. Metal Arc will, however, file a damage claim with the carrier on your behalf.

Carriers often impose rigid timelines for making a freight damage claim. Accordingly, failure to inspect the package upon receipt and/or failure to contact Metal Arc immediately upon discovering freight damage may prevent the purchaser and Metal Arc from successfully pursuing a freight damage claim.

In order to pursue a claim, it also will be necessary for the purchaser to retain the original packaging and possibly provide pictures of the damaged part(s) and packaging. Failure to retain the packaging also may prevent the purchaser and Metal Arc from successfully pursuing a freight damage claim.

In no circumstance may a buyer make a deduction for freight damage when paying a Metal Arc invoice.

Invoicing and Payment Terms: Orders are invoiced at the time of shipment. Invoices are due within 30 days from the invoice date. Invoices unpaid after 30 days are subject to a late charge of 2% per month on the unpaid balance. The calculation of this late charge begins on the 31st day from the invoice date. At Metal Arc's discretion, customers with unpaid (delinquent) balances may be placed on credit hold. Metal Arc reserves the right to adopt different payment terms with particular customers on a case-by-case basis.

<u>**Taxes</u>**: Metal Arc's prices do not include taxes, and all sales, use, and other applicable taxes are the sole responsibility of the purchaser. Metal Arc will invoice and collect sales taxes for all sales made in Michigan, unless the purchaser has provided Metal Arc with an appropriate certificate of exemption.</u>

Warranty: Metal Arc warrants that its office furniture products will be free from defects in material and workmanship for the life of the products. Metal Arc, as its sole obligation, will repair or replace (at its option) any product, part or component which fails under normal use as a result of such a defect in material or workmanship. This warranty extends only to original purchasers who acquire new product directly from Metal Arc or its authorized resellers. This warranty is void if the original purchaser transfers or sells the product.

This warranty does not cover damage resulting from ordinary wear and tear, including paint finish changes and/or discoloration resulting from aging or exposure to light. In addition, this warranty does not cover damage resulting from improper installation or use of a product, and any material modification to the original product voids this warranty.

This warranty does not cover other manufacturers' products sold through Metal Arc. Rather, supplier warranties will apply to products not manufactured by Metal Arc.

TO THE EXTENT ALLOWED BY LAW, ANY IMPLIED WARRANTIES, INCLUDING ANY WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, ARE HEREBY DISCLAIMED.

This warranty does not cover, and Metal Arc shall not be liable for, incidental damages such as loss of time, loss of use, or inconvenience. In addition, this warranty does not cover, and Metal Arc shall not be liable for, any consequential damages (*e.g.*, the cost of fixing other property) caused by its products.

This warranty gives the purchaser specific legal rights. Purchasers may have other rights which vary from state to state or province to province.
